Mumeishi Kendo Club Mumeishi 3's Competition Terms and Conditions

Please read the following participant terms and conditions carefully before applying to participate in the kendo competition organised by Mumeishi Kendo Club ("Mumeishi"). By submitting your application, you acknowledge and agree to be bound by these terms and conditions.

1. Competition Rules and Regulations:

- 1.1. The competition will be conducted in accordance with the rules and regulations set forth by the British Kendo Association ("BKA") and the International Federation of Kendo ("IFK"). Participants must familiarise themselves with these rules and comply with them during the competition.
- 1.2. Participants must adhere to all instructions given by Mumeishi and/or any other officials ("Officials") present at the competition, such as shimpan/referee, at all times during the event.

2. Accuracy of Information:

2.1. Participants are responsible for providing accurate and up-to-date information during the application process. Mumeishi will not be held liable for any consequences arising from the provision of false or misleading information.

3. Fee:

- 3.1. Participants are required to pay an application fee to secure their participation in the competition. The fee amount may be subject to change from time to time. Payment instructions and deadlines will be communicated separately.
- 3.2. The registration fee is non-refundable.
- 3.3. Subject to the above, if the competition is cancelled by Mumeishi due to unforeseen circumstances, a refund or alternative arrangement may be provided at the sole discretion of Mumeishi.

4. Personal Responsibility and Medical Emergencies:

- 4.1. Participants understand and acknowledge that they are responsible for their own physical condition, physical fitness, and overall well-being during the competition. It is their responsibility to ensure that they are physically and mentally prepared and capable to participate in the event.
- 4.2. Participants should exercise caution and act responsibly during the competition to avoid injury or harm to themselves or others. Any negligent, reckless or dangerous behaviour that may cause harm to fellow participants, staff, Officials or spectators will not be tolerated.
- 4.3. In the event of a medical emergency during the competition, Mumeishi will make reasonable efforts to provide assistance. Participants hereby authorise Mumeishi and its affiliates and/or contractors to provide details (including details of any incident or medical treatment) to medical personnel as required.
- 4.4. Participants acknowledge that they participate in the competition at their own risk and agree to assume full responsibility for any medical expenses or treatment arising from injury or illness incurred during the event.

4.5. Participants are strongly advised to obtain their own personal medical insurance coverage to protect themselves against any potential medical expenses or liabilities that may arise during their participation in the competition.

5. Limitation of Liability:

- 5.1. To the maximum extent permitted by law, Mumeishi shall not be liable for any indirect, consequential, or special damages arising out of or in connection with your participation in the competition, including but not limited to loss of profit, loss of business, business interruption, or any other loss of business opportunity.
- 5.2. Subject to applicable law, Mumeishi's total liability to you in connection with the competition, whether in contract, tort (including negligence), or otherwise, shall not exceed the application fee paid by you for participation in the competition.
- 5.3. Participants agree to indemnify and hold Mumeishi, its organisers, staff, volunteers, members and affiliates harmless from any claims, damages, or liabilities arising from their participation in the competition, including but not limited to personal injury, loss of property, or any other harm incurred during the event.
- 5.4. Nothing in these terms and conditions seeks to exclude or limit Mumeishi's liability for death or personal injury caused by its negligence, fraud, or any other liability that cannot be excluded or limited under applicable law.

6. Disqualification:

- 6.1. Mumeishi reserves the right to refuse any application and/or participation at any time if there is a breach and/or non-compliance with any of the clauses contained in these terms and conditions, or if the participant fails to comply with the rules and regulations of the BKA, the IFK, or any applicable laws and regulations.
- 6.2. Mumeishi reserves the right to refuse your application and/or participation if, in its sole opinion, the action or activity you do, anticipate doing, or have done is likely to cause offence. This includes any discriminatory, insulting, racist, religious, political, or other illegal/prohibited messages or behaviour.
- 6.3. Participants acknowledge and accept that Mumeishi has sole discretion to offer or not offer any recourse in the event of refusal or disqualification.

7. Photography and Videography:

7.1. Participants acknowledge and consent to the use of photographs, videos, or other media captured during the competition for promotional purposes by Mumeishi or its affiliates. These materials may be used in print, online, or in any other medium to promote future events or the activities of kendo and/or Mumeishi.

8. General:

- 8.1. Mumeishi reserves the right to modify or amend these terms and conditions at any time. Any changes will be posted on our website and/or circulated to participants.
